**OUR MISSION IS** "...to plan and initiate development of our area through the promotion and facilitation of cooperative activities dedicated to the social, environmental and economic well being of our citizens and communities."

### **LOAN INFORMATION AND FEES**

- 1. Maximum Loan of \$500,000 available for start-up, maintenance or expansion
- 2. Interest Rate may vary based on Loan Portfolio.
- 3. Loan Application Fee of 1% of loan amount requested minimum \$50.00
- 4. \$10 per credit check (each applicant and each spouse) will be collected once the loan application has been accepted by Community Futures Sun Country (fees collected for credit checks will be applied to the 1% application fee)
- 5. No Pre-payment Penalties

#### SPECIFIC CRITERIA MUST BE MET:

- 1. Location of the business must be in the Sun Country region.
- 2. Future economic viability of the business;
- 3. Competent management;
- 4. Reasonable personal financial investment and adequate security for the venture;
- 5. Employment creation or maintenance for predominantly local residents, and
- 6. Life Insurance in the amount of the loan may be required before funds will be disbursed.

#### YOUR STEPS TO GETTING A LOAN:

- 1. Complete LOAN APPLICATION. Ensure you include supporting documentation as is outlined in the application. If you have any questions contact the Community Futures Sun Country Office.
- 2. Each applicant must complete a PERSONAL OVERVIEW.
- 3. If a Co-signer is needed for the Loan, have that person complete the GUARANTOR'S OVERVIEW.
- 4. Once the first applications are completed return them to the Community Futures Sun Country office with \$10.00 for each applicant, each spouse, and each guarantor. Example: if a married individual applies for a loan and is having their father co-sign, there will be an initial charge of \$30.
- 5. When the Loans Officer has completed reviewing the application, WE WILL CALL to advise you of whether or not we can proceed with the application.
- 6. Submit a complete and comprehensive BUSINESS PLAN to the Community Futures Sun Country office with the rest of the Loan Application Fee.
- 7. The Loans Officer will put together a PACKAGE TO PRESENT for adjudication.
- 8. If DECLINED you have the right to appeal this decision.
- 9. If APPROVED the appropriate documentation will be completed, signed and funds will be disbursed.

# APPLICANT INFORMATION

NOTES: (1) Applicants are not **required** to provide your Social Security Number (SIN), however, it will improve the accuracy of information obtained for your file and is requested by CFSC; (2) Spousal information is required for common-law and married individuals for initial assessment purposes, regardless of their involvement in the business; (3) a supplementary Principals Sheet will be provided and must be filled out for businesses that have more than two principles; (4) a TEN DOLLAR (\$10) PER INDIVIDUAL initial assessment fee is charged up front and must be submitted with your signed application form – **Example**: A company with an unmarried director, as well as one married director must submit an initial assessment fee of \$40 to cover the company (\$10), the single director (\$10), the married director (\$10), and the married director's spouse (\$10).
